

RESOLUTION # 3-20

BEFORE THE BOARD OF TOWNSHIP TRUSTEES OF TROY TOWNSHIP, RICHLAND COUNTY, OHIO

A RESOLUTION TO PROVIDE ALTERNATIVE PUBLIC ACCESS TO TRUSTEE PUBLIC MEETINGS DURING THE FEDERAL AND OHIO COVID-19 PUBLIC HEALTH EMERGENCY.

Whereas, the Ohio Attorney General has advised local governments they may consider alternatives to the availability of public access to public Township meetings during declared emergencies, and

Whereas, a Federal and Ohio Public Health Emergency is now in effect limiting gathering to no greater than ten(10) persons, and

Whereas, the Township meeting place is not suited for the recommended 6' spacing of persons.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TOWNSHIP TRUSTEES OF TROY TOWNSHIP, RICHLAND COUNTY, OHIO:

SECTION 1. That during the present declared Federal and Ohio Public Health Emergency, all public Township meeting held under Ohio R. C. 121.22 shall be held with actual attendance limited to Township Trustees, Fiscal Officer, other Township officials or employees, and necessary invitees to conduct Township public business.

Section 2. Public physical attendance at the meeting shall be limited or excluded depending on the availability of safe public spacing in relationship to the number of persons present that are necessary to conduct the Township's business.

Section 3. Any public person desiring to attend such meeting whose attendance is limited or excluded by the emergency shall be given real time access to the meeting by calling (419) 884-2260.

Section 4. That this Resolution shall be posted on the Township Hall entry door, Township bulletin board, and Township web page.

At the regular meeting of March 30, 2020, Trustee Jeff Carter moved for adoption of the foregoing Resolution, seconded by Trustee Mike Schuster and upon roll call vote the vote was 3 aye 0 nay.
