    - 40 hours worked instead of 40 hours paid so the employees get overtime if an employee uses a vacation or a sick day that week.
    - Sick time 4.6 hours earned per pay instead of 2.0 hrs.
    - The county has no cap on their sick time. Currently, the Township employees get capped at 320 hours per the current language in the employee handbook.
