Road Report from Mr. Thayer, Road Superintendent

Mr. Thayer emailed the road report to the trustees, fiscal officer, and assistant fiscal officer prior to the meeting.

- The road crew completed the following tasks since last meeting:
 - o Finished mowing the right-of-way on the south end
 - o Changed a failed cross pipe on Eckert Rd.
 - Reassembled the berm belt
 - Dug a grave at the cemetery
 - o Helped Perry Township do ditching
 - Washed the F-250 and the F-550
 - Power washed the new concrete pad
 - Put more steel pipe couplings on the Eckert Rd. cross pipe
 - Started mowing the right-of-way on the north end
- GT Contracting finished crack sealing on Bowers, Kings Corners, Cockley, and Greibling Roads.
- When the road crew was returning to the garage after changing the cross pipe on Eckert Rd., a walnut fell and cracked the corner of the windshield on the F-550.

Mr. McCready noted he will discuss the windshield damage and repair with Mr. Thayer to ensure we are in communication with the insurance company.

Chief Compton also shared the following updates:

- To promote fire safety week, the fire department attended a public relations event last week at Western Elementary and will attend an event this week at Eastern Elementary.
- VASU installed repeaters last week, which is the last expenditure for the MARCS grant. There will be some grant money left over which the department will use to purchase extra batteries for their devices.

Assistant Chief Ross shared the following updates:

- Engine 142 repairs should be completed today or tomorrow within the estimated cost previously approved.
- There was a sewer backup recently at the station. Keith's Drain and Septic came out to snake the line. Keith's will return to camera the line and repair the cap.

Correspondence

The Township has received the following correspondence items since the last meeting:

- Email from Traveler's Insurance's collection agency to Ms. Michalski following up on the letter they previously sent the Township the Township has no liability for the recently paid insurance claims and the letter implying that the Township was liable was sent in error.
- Letter from State of Ohio Department of Taxation denies the Township's refund request relating to 2021 employment taxes, which Ms. Michalski filed when it was discovered in early 2025. Ms. Michalski and Mrs. Wilkinson will follow up with the state.
- Letter from Village of Lexington notification of a meeting on at 5:00 pm on October 21, 2025 at the Lexington Senior Civic Center (the Depot) regarding the State Route 97 connector project.
- Information from Richland County Commissioners distributed during the public meeting on Thursday, October 9, 2025, regarding the potential new property tax abatements if both piggyback abatements are implemented in full by the end of October, the Township will lose \$30,995 in annual revenue, beginning in January 2026. If the abatements are implemented after the end of October, they will not take effect until the second half of 2026. The Commissioners have the option to offer one, both, or no abatements, at any amount up to 2.5% each. The Commissioners will hold another meeting to get input from the public prior to making a decision.
- Email regarding employee benefits enrollment dates are November 3-7, 2025. A benefits fair will be held on October 22nd and CEBCO meetings will be held on October 28th and 29th.
