Chief Compton also shared the following updates:

- The Fire Department received a new employment application for firefighter/EMT Kyle Johnson
- Katlin Daugherty is now a paramedic with a new pay rate of \$21 per hour, effective 10/16/2025.
- Chief Compton received a letter from United Healthcare regarding ambulance service reporting through their portal. He discussed the letter with Debbie at Medicount, who said she will take care of the reporting on her end. The township does not need to do anything with the portal.

Mr. McCready made a motion to hire Kyle Johnson as a new part-time firefighter/EMT at a rate of \$21 per hour, effective 11/10/2025. Mr. Wittmer seconded the motion, and the motion carried with a roll call vote of all ayes.

Discussion of holiday events and gifts for firefighters: As in 2024, there will not be a holiday party due to scheduling conflicts, and the township will instead give gift baskets or something similar that falls under the IRS payroll reporting threshold of \$25.

Finances

Mr. Wittmer made a motion to pay bills. Mr. Schuster seconded the motion and the motion carried with a roll call vote of all ayes.

Ms. Michalski, Fiscal Officer and Mrs. Wilkinson, Assistant Fiscal Officer

- Received signed payroll sheet from Chief Compton for prior pay.
- 2026 Appropriations & Planning:
 - The Fiscal Officer recently received notification from the county that 2026 benefits payments will increase 14% from 2025. The Township will consider increasing employee cost sharing portion to 10% for all full-time employees and all elected officials.
 - Road and Bridge employee pay raises have historically averaged 3% per year and Fire/EMS employee pay raises historically averaged 9.7% per year over the past several years. Currently, 2026 appropriations estimates are based on these percentages; however, final appropriation amounts will be revised to reflect actual projected pay raises.
 - Meeting attendees discussed the upcoming annual contract renewal with Perry Township for EMS services. Chief Compton will compute the appropriate dollar amounts to include in the contract and will provide the amounts to the Fiscal Officer and Assistant Fiscal Officer.
 - Meeting attendees discussed continuing the relationship with law firm Brosius, Johnson & Griggs in 2026. The firm specializes in fire issues, and the township has also used them in the past. The Township will likely continue this relationship for 2026.

NEW BUSINESS

Mr. Wittmer:

• Mr. Wittmer discussed trimming tree branches shading the roads while they're still small. The roads will likely stay in better condition if the trees are regularly trimmed so they can have more sun exposure. Mr. Wittmer suggested choosing one road per year on which to trim trees to properly maintain them. The Township doesn't have equipment to reach many of the branches and will need to work with a tree service for this project. The Township has worked with Bob Sharp in the past on tree removal and will consider consulting with him on the trimming as well.

Mr. Schuster:

• Mr. Schuster expressed concern over the potential loss of property tax funds in the event that Township residents vote to eliminate property taxes if they are included on the ballot in November 2026.

Mr. McCready:

Mr. McCready suggested disseminating a flyer or some other type of informational document to
residents that explains 1) what the Township does with property taxes and 2) the services the Township
provides for its residents using the tax revenue.

OLD BUSINESS:

Chief Compton provided an update on the status of the Fire/EMS employees' signed cybersecurity
policy acknowledgements. He has received some and is currently waiting on five more. He will send
them all to the Fiscal Officer and Assistant Fiscal Officer when received.
